

**Rules, Restrictions and Limitations**  
**Virginia Natural Gas Sponsored Gas Stove Giveaway**  
**2018 Homearama at The Creeks of Nansemond**

1. The "Gas Stove Giveaway" is sponsored Virginia Natural Gas ("Sponsor"). The retail value of the prize is approximately \$1600. A picture of the prize will be on display at the show and on the show's website. To include delivery but not installation.
2. No purchase necessary but must come to the show site to enter.
3. One winner will be selected within 72 hours of the close of the show, through random drawing, no purchase is necessary to enter to win. The winner agrees their name and city where they live may be publicized. The address of the property will not be publicized. To be eligible, the submission form must be filled out completely, including name, address, phone number, email address and questions answered.
4. The winner agrees to be photographed as a part of the event publicity at the time of delivery.
5. The Prize winners must:
  - **Be 21 years of age or older**
  - **Be the primary owner of the residence where the prizes will be delivered.**
  - **Reside in the home where the prize will be delivered.**
  - **Must be occupied by the prize winner - rental properties are not eligible**
  - **The winner must reside within the Virginia Natural Gas service territory.**
6. The winner is responsible for all installation costs.

("TBA") and its affiliated entities, directors, officers, agents, and employees (collectively, TBA Group"), are not liable for any claims, damages, losses or injuries, including any third party claims, arising from or relating to, in whole or in part, the Giveaways, delivery of any prize or any dispute with Lowe's or any installer. All entrants further agree that in the event of any claims, damages, losses or injuries, arising from or relating to participation in this Giveaway, entrant will not sue or assert any claim against any member of the TBA Group and entrant will indemnify and hold harmless each member of the TBA Group from and against any and all such claims, including reasonable attorneys' fees related thereto.
